#### Re: SRIRACHA HOT CHILI SAUCE RECALL

This is to inform you of a product recall involving Huy Fong Foods, Inc.'s Sriracha Hot Chili Sauce, 17 oz. and 28 oz. codes **H9TMKA, H9TMNA, H9TMLA, H9TMJA-H9TMJB** with a Best Before Date of March 2021. This recall is being implemented with the knowledge of the Food and Drug Administration. Please read and follow this letter in its entirety.

This recall has been initiated due to lactic acid buildup causing certain bottles to "bloat" and continue to ferment. Although not all bottles from all the batches are affected, we are advising you to avoid opening any bottles that appear or feel "bloated". Failing to comply to the recall may result in further complaints from your customers of the product splattering on walls, furniture, carpet, etc. or eyes when opening the affected Sriracha bottles. However, be assured that the affected products do not pose a food safety issue.

The product code listed above were shipped between 4/26/19 - 6/28/19. Please immediately examine your inventory and quarantine the product that is subject to the recall and contact our sales department at <a href="mailto:sales@huyfong.com">sales@huyfong.com</a> for a resolution. Please see attached product labels (U.S.A.) for ease in identifying the product at retail/user level. You may have no inventory or very little inventory left of these codes since these were produced in the earlier part of this year.

In addition, if you may have further distributed this product, please identify your customers and immediately notify them of this product recall. Your notification to your customers may be assisted by including a copy of this recall notification letter. Your notification must include instructions to your customers as to the withdrawal and disposal of the recalled product. This recall should extend all the way down to the retail level.

You are required to confirm receipt of this letter <u>by either email at sales@huyfong.com or fax</u> <u>at (626) 286-8522</u> to acknowledge reading and receipt of the recall notification. Further, in about a week's time, FDA requires that we also send you an "Effective Letter and Questionnaire", which you are required to complete and return to us. FDA requires these documents to follow the progress of the recall.


